3. ICG has the sole right to reject my bid even if my/our rates are higher than that of other bidders.
4. I/we will pay the full amount by cash/ DD within 2 days if my/our offer is accepted. ICG reserves the right to cancel my/our offer if I/we fail to pay the amount indicated in the offer.
5. I/we agree to submit the offer along with a non-refundable form fees of Rs. 100/- in cash failing which my/our offer may be rejected.
6. I/we agree to submit, along with the offer, EMD in the form of DD from nationalized banks of an amount equal to 5% of my/our quoted amount for one or more lots of items failing which my/our offer may be rejected.
7. I/we agree that if my/our quote for one or more lot is less than the minimum expected market value of that lot/(s) as determined by ICG for an individual item or for the lot as a whole, then my/our offer may be rejected.
8. I/we understand that the items that I/we bid successfully on are to be picked up at ICG premises during office hours and within 2 days of making the payment failing which ICG will have the right to reject my/our claim and the amount paid will be forfeited.
9. All charges for loading, unloading, transportation etc. will be borne by me/us and ICG is not responsible for the same.
10. I/we understand that I/we am/are required to superscribe on the sealed envelope the Serial Nos. of the lot/(s) quoted along with the DD amount for the same.
11. I/we understand that no sale transaction with any third party can be done inside ICG premises including with ICG staff.
12. I/we will take all necessary papers such as payment receipts, gate pass etc. before leaving ICG.
13. ICG will not be responsible for any damages or repair service for any of the items once the items are purchased and taken out of ICG.
14. ICG reserves the right to deduct or add 'item rate amount' if in case quantities at the site are found short or in excess of the stated quantities. I/we understand that I/we can choose or not to pay for the extra quantity based on the individual item rate amount; in case the quantity is less than what is stated, an appropriate deduction based on item rate amount will be made.

15. All the name plates, identification tags and logos of ICG will be removed before loading the items.
16. In case of any dispute, the decision of ICG will be final and binding.
17. ICG reserves right to penalize me/us for any damages done to ICG property during handling, loading and transportation of the items.
18. I/we agree that tender may be opened by ICG any time after the prescribed time whether or not I/we am/are present for the tender opening.
